COURSE DESCRIPTION

This Seminar is organized around the main theme of judging fairly and responsively when faced with difficult cases involving women living at the margins because of poverty, addictions or mental health issues. Sessions will focus on practical strategies for effective communication (including with self-represented litigants); understanding the contexts of vulnerable women; and problem-solving approaches at the disposition stage. Additional themes of contemporary relevance will be explored in other sessions including: the role, if any, that culture should play in judicial decision-making; equality debates in recent cases such as those involving prostitution, polygamy, and face coverings; and what it means to judge courageously when faced with contentious cases. A conversation between retired Supreme Court Justices Claire L'Heureux-Dubé and Marie Deschamps will be a highlight on the final morning.

COMMUNICATING WITH VULNERABLE WOMEN

The process by which decisions are made and communicated can profoundly affect the way in which people appearing in court experience the judicial system. This is especially the case when social, cultural, economic or systemic factors create layers of vulnerability and when litigants are self-represented. This segment of the program will focus on successfully communicating with vulnerable women. First, we will examine situations involving women with mental health issues and the reaction such situations can provoke. We will then turn to communication strategies that judges can use when communicating with vulnerable litigants. We will apply the insights of problem-solving jurisprudence in this theme. We will end with a discussion of self-represented litigants and associated evidentiary challenges.

CHOOSING (OR LOSING IN) EQUALITY?

Debate

What does it mean to view equality as a fulcrum right against which 'choice' and 'harm' is assessed? Does decriminalization of certain social practices enhance women's equality (by recognizing and removing them from secondary harms)? Does equality mean women and men should be free to choose certain social practices? Languages of 'choice' and 'freedom' (and culture) are gaining traction in the framing of equality cases. What do they mean and how do they square with jurisprudence and Charter values as articulated therein? Our point of departure will be recent cases where contrasting views of harm, choice, and equality have been presented (eg., prostitution, polygamy, common law marriage, and face coverings).

JUDGING AND CHANGE

This session will include a conversation between retired Supreme Court Judges, The Honourable Claire L'Heureux-Dubé and Marie Deschamps. Our purpose is to examine the impact on them and other judges who take "the path less followed" in response to newer/expanded understandings of justice, fairness, social change and social inclusion. We will consider how extensively Justice L'Heureux-Dubé's dissents in particular have become law/have changed the law. Pushing against established bodies of legal principle can often entail a delicate balance of courage and resilience when those decisions are unpopular. The parameters of judicial method in providing structure and collegiality in providing support in the process of legal change will be considered and opened for discussion from the plenary group.
